## 4. First-aid measures

<b>Inhalation</b>	Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. If respiratory tract irritation, dizziness, nausea, or unconsciousness occurs, seek immediate medical assistance. If breathing has stopped, assist ventilation with a mechanical device or use mouth-to-mouth resuscitation. Get medical attention if breathing difficulty persists.
<b>Skin contact</b>	Not likely, due to the form of the product. If frostbite occurs, immerse affected area in warm water (not exceeding 105°F/41°C). Keep immersed for 20 to 40 minutes. Get medical attention immediately.
<b>Eye contact</b>	Not likely, due to the form of the product. If frostbite occurs, immediately flush eyes with plenty of warm water (not exceeding 105°F/41°C) for at least 15 minutes. If easy to do, remove contact lenses. Get medical attention promptly if symptoms persist or occur after washing.

<b>Most important symptoms/effects, acute and delayed</b>	Symptoms of overexposure can include shortness of breath, drowsiness, headaches, confusion, decreased coordination, visual disturbances and vomiting, and are reversible if exposure is stopped. Continued exposure can lead to hypoxia (inadequate oxygen), cyanosis (bluish discoloration of the skin), numbness of the extremities, unconsciousness and death. Exposure to rapidly expanding gas or vaporizing liquid may cause frostbite ("cold burn").

## 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Water fog. Water spray. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).
<b>Unsuitable extinguishing media</b>	Do not use water jet as an extinguisher, as this will spread the fire.
<b>Specific hazards arising from the chemical</b>	Extremely flammable gas. Containers may explode when heated. During fire, gases hazardous to health may be formed.
<b>Special protective equipment and precautions for firefighters</b>	Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with full face-piece operated in positive pressure mode. Use approved gas detectors in confined spaces.
<b>Fire fighting equipment/instructions</b>	In case of fire and/or explosion do not breathe fumes. Do not extinguish fires unless gas flow can be stopped safely; explosive re-ignition may occur. Promptly isolate the scene by removing all persons from the vicinity of the incident. No action shall be taken involving any personal risk or without suitable training. For fires involving this material, do not enter any enclosed or confined fire space without proper protective equipment, including self-contained breathing apparatus. Stop flow of material. Use water to keep fire exposed containers cool and to protect personnel effecting shutoff. If a leak or spill has not ignited, use water spray to disperse the vapors and to protect personnel attempting to stop leak. Prevent runoff from fire control or dilution from entering streams, sewers or drinking water supply.
<b>Specific methods</b>	Evacuate area. Check oxygen content before entering area. Stop leak if you can do so without risk. Remove pressurized gas cylinders from the immediate vicinity. Turn leaking cylinder with the leak up to prevent escape of gas in liquid state. Closed containers can burst violently when heated, due to excess pressure build-up. Use water spray to keep fire-exposed containers cool.
<b>General fire hazards</b>	Extremely flammable gas. Contents under pressure. Pressurized container may explode when exposed to heat or flame.

## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures</b>	Eliminate all sources of ignition in vicinity of released gas. Evacuate all non-essential personnel to an area upwind. Stop leak if possible without any risk. Ventilate enclosed areas to prevent formation of toxic, flammable or oxygen deficient atmospheres. Use suitable protective equipment (section 8). Follow all fire-fighting procedures (section 5). Keep out of low areas. Many gases are heavier than air and will spread along ground and collect in low or confined areas (sewers, basements, tanks). Wear appropriate protective equipment and clothing during clean-up. Emergency personnel need self-contained breathing equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Local authorities should be advised if significant spillages cannot be contained.
<b>Methods and materials for containment and cleaning up</b>	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Stop leak if you can do so without risk. If possible, turn leaking containers so that gas escapes rather than liquid. Isolate area until gas has dispersed. For waste disposal, see section 13 of the SDS.

**Environmental precautions** Prevent further leakage or spillage if safe to do so. Attempt to stop the gas leak, if no risk is involved.

## 7. Handling and storage

**Precautions for safe handling** Eliminate all sources of ignition. Before entering storage tanks and commencing any operation in a confined area, check the atmosphere for oxygen content and flammability. Valve protection caps must remain in place unless container is secured with valve outlet piping to use point. Close valve after each use and when container is empty. Do not drop, drag, slide or roll cylinders on their sides. Use a suitable hand truck to move gas containers. Use a pressure reducing regulator when connecting container to piping or systems. Never insert an object (e.g. wrench, screwdriver, pry bar) into cap openings. Use an adjustable strap wrench to remove over-tight or rusted caps. Open valve slowly. Do not use gas directly from containers. Do not heat container by any means to increase the discharge rate of product from the container. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not enter storage areas or confined spaces unless adequately ventilated. Use only outdoors or in a well-ventilated area. Oxygen concentration should not fall below 19.5 % at sea level (pO<sub>2</sub> = 135 mmHg). All equipment used when handling the product must be grounded. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.

**Conditions for safe storage, including any incompatibilities** Keep away from heat, sparks and open flame. Store in a cool, dry place out of direct sunlight. Secure cylinders in an upright position at all times, close all valves when not in use. Store in original tightly closed container. Store in a well-ventilated place. Store away from incompatible materials (see Section 10 of the SDS).
